1. Operator Information

2. Booking and Payment

- 2.1 All bookings must be made through our official website or directly at our venue.
- 2.2 Full payment is required at the time of booking. We accept major debit/credit cards and secure online payment methods.

- 2.4 A confirmation email will be sent after a successful booking. This must be presented (printed or digital) upon arrival.

3. Refunds and Transfers

- 3.1 All bookings are strictly non-refundable and non-transferable, including in cases of illness, late arrival, or inability to attend for any reason.
- 3.2 By completing your booking, you confirm that you accept this policy without exception.

4. Group Bookings

- 4.1 For operational reasons, **large groups may be divided into smaller groups** to ensure a smooth flow through the course.
- 4.2 We will do our best to accommodate group requests, but final arrangements are at the discretion of management for safety and scheduling purposes.

5. Arrival and Participation

- 5.1 Guests must arrive at least 10 minutes prior to their scheduled booking time.
- 5.2 Late arrivals may lose part or all of their session without refund.
- 5.3 All players must follow staff instructions and posted safety guidelines at all times.
- 5.4 **Staff instructions must be listened to and respected**. We reserve the right to refuse entry or ask individuals to leave if behaviour is unsafe, disruptive, or disrespectful.

6. Children and Supervision

- 6.1 Children under 12 must be supervised by a paying adult.
- 6.2 Parents and guardians are fully responsible for the behaviour and safety of children in their care.

7. Health and Safety

- 7.1 Participation is at your own risk. Jungle Monkeyz Enterprise Limited accepts no liability for injuries resulting from failure to follow safety rules or improper use of equipment.
- 7.2 Please wear appropriate footwear and behave responsibly during play.
- 7.3 Do not participate if unwell or under the influence of alcohol or drugs.

8. Liability

- 8.1 Visitors must keep personal belongings with them at all times or in the lockers provided. We accept no responsibility for the loss, theft or damage to any personal items brought into the Attraction or left in lockers. Please take care not to leave belongings behind or unattended, and please do not bring valuables to the Attraction.
- 8.2 By accepting these Terms Visitors agree not to hold the management, directors, shareholders or staff of Jungle Monkeyz Adventure Golf responsible for any accidents; injury; loss or damage whilst on the premises. Visitors engage in activities at their own risk and hereby agree to accept full responsibility for themself and/or anyone in their booking and consent for anyone under the age of 18 that they purchase a ticket for (if applicable) during participation at the Attraction.
- 8.3 We accept no responsibility for death or personal injury resulting from our negligence and for fraud or fraudulent misrepresentation. Other than this, we shall not be responsible for any type of loss or damage which you may suffer or incur as a direct or indirect result of purchasing tickets from us or visiting the Attraction. We accept no responsibility for any distress, inconvenience or anxiety experienced by visitors during the course of the Attraction and/or during evacuation from the Attraction in the unlikely event of a breakdown or accident.
- 8.4 Accompanying adults accept responsibility for any damage done to any facilities or equipment within the Attraction by either them or children they are supervising, and will compensate us for the cost of remedying the same.

We will not be liable for the time or expense in attending the Attraction in the event of such a cancellation or access restriction.
